#2 - Presentation of FY 2019-20 Audit

A meeting with the auditor and the bookkeeper is being arranged to discuss and correct this problem. The audit also noted that the audit report was not filed in PARIS in a timely manner. Future audit reports will be filed in PARIS as required. The auditor recommendations were also noted. To avoid the occurrence of funds being declared dormant by a depository, the auditor recommended utilizing on-line accounts so as to be able to regularly log into and monitor bank accounts. #4-Consultant Updates

Elizabeth Kraus-H. Sicherman & Company

Elizabeth highlighted the following business contacts and referred the Board to the latest update report dated February 2, 2021.

<u>First Friends Day Care</u>: The CEDC loan program was explained to the owner of the business. Elizabeth is waiting for the owner to provide more information so a conference call can be scheduled to discuss the company's needs and the loan program in more detail.

Big Ditch Brewing Company: The Company prefers to wait until COVID restrictions are eased. The project site is on Transit Road. The project has a cost of \$40 million with the company looking for up to \$500,000 from the CEDC for new equipment. Contact will be maintained with the company.

<u>Barkology</u>: The project consists of a dog park and kennel services. The owner is looking for a grant and is not interested in a loan.

<u>Hanzlian Sausage Company</u>: This loan was closed in August, 2020 for \$150,000. H. Sicherman & Company is monitoring job creation. An ownership change is planned but will not affect the loan or the project.

Amy Vigneron, Cohen & Lombardo

Amy provided on the following matters.

<u>Global Asset Management</u>: John Harrington is suing Kevin Garvey, his former partner regarding the Company's profit sharing arrangement. The CEDC has been released from involvement in this suit.

<u>Buffalo Bread Company</u>: The CEDC maintains a lien on the Richard Costanzo's property, but is subordinate

to the liens of Key Bank and M&T.

<u>Insurance Coverage for Board Members</u>: Amy has discussed this matter with the Town of Cheektowaga attorney, who referred her to the Town Accountant, Brian Kraus.

<u>New York State Subpoena of CEDC Records</u>: The state attorney has requested and Amy agreed to accept the state subpoena via email. Amy also said the state agreed to a mid-March extension for submitting the requested information.
